NOW, THEREFORE, BE IT RESOLVED and hereby determined by the Board of Education of the Big Walnut Local School District, Delaware County, Ohio, that:

- Section 1. It is necessary for the purpose of constructing school facilities; renovating, improving and constructing additions to school facilities; furnishing and equipping the same; improving the sites thereof; and acquiring land and interests in land to issue and sell bonds of the School District in an amount not to exceed \$135,000,000 (the "Bonds").
- Section 2. The School District requests consents of the Tax Commissioner of Ohio and the Superintendent of Public Instruction to issue bonds in excess of 4% but not to exceed 9% of the tax valuation of said School District, all in accordance with Ohio Revised Code ("Revised Code") Section 133.06.
- Section 3. The School District is hereby declared to be a "special needs" district within the meaning of Revised Code Section 133.06(E) because the student population of the School District is not being adequately serviced by the existing permanent improvements of the School District and the School District cannot obtain funds within the limitations of Revised Code Section 133.06(B) to provide additional facilities to meet such needs.
- Section 4. The School District requests consents of the Tax Commissioner of Ohio and the Superintendent of Public Instruction to issue bonds in excess of 9% of the tax valuation of said School District, all in accordance with Revised Code Section 133.06.
- Section 5. The Board intends to submit the question of issuing the Bonds to the electors of the School District at the election to be held at the usual voting places within the School District on November 8, 2016.
- Section 6. All formal actions of this Board concerning and relating to the passage of this resolution were adopted in an open meeting of this Board, and all deliberations of this Board and of any of its

committees that resulted in such formal action wer legal requirements, including Revised Code Section	re in meetings open to the public in compliance with all 121.22.
