RESOLUTION DECLARING TRANSPORTATION TO BE IMPRACTICAL FOR CERTAIN IDENTIFIED SCHOOLS (R.C. Section 3327.02)

WHEREAS, On August 15, 2019, the Board passed a resolution declaring the students identified below to have been determined to be residents of this school district and eligible for transportation services; and

WHEREAS, after a careful evaluation of all available options, it has been determined that it is impractical to provide transportation for these students to their selected schools; and

WHEREAS, the following factors as identified in Revised Code Section 3327.02 have been considered:

- 1. The time and distance required to provide the transportation
- The number of pupils to be transported
 The cost of providing transportation in terms of equipment, maintenance, personnel, and
- 4. Whether similar or equivalent service is provided to other pupils eligible for transportation
- 5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules
- 6. Whether other reimbursable types of transportation are available; and

WHEREAS, the option of offering payment-in-lieu of transportation is provided in Ohio Revised Code:
