The Board of Education of the Big Walnut Local School District (the "Board"), Delaware County, Ohio (the "School District"), met in Regular Virtual Session on May 21, 2020, at 6:30 p.m., with the following members present:

**RESOLUTION TO ALLOW FOR THE CONTINUITY OF SERVICES**

WHEREAS, Ohio Governor, Mike DeWine, declared a state of emergency on March 9, 2020 due to concerns over the spread of Coronavirus; and

WHEREAS, the World Health Organization on March 11, 2020, officially declared the Coronavirus outbreak a pandemic; and

WHEREAS, Ohio Governor, Mike DeWine, ordered the closure of all Ohio public, private and charter schools to students beginning at the end of business on March 16, 2020 through at least April 3, 2020; and

WHEREAS, Ohio Director of Health, Dr. Amy Acton, issued a statewide stay-at-home order for non-essential business to take effect from midnight on March 23, 2020 through at least April 6, 2020, and on April 2, 2020, extended that order through at least May 1, 2020; and

WHEREAS, On March 30, 2020, Ohio Governor, Mike DeWine, ordered the extension of the school closure through at least May 1, 2020, and on April 20, 2020 ordered an extension for the remainder of the school year; and

WHEREAS, the Big Walnut Local School District Board of Education recognizes the importance of public schools to the community and remains steadfast in its commitment to provide instruction, coaching, and other services through virtual means or modified work schedules; and

WHEREAS, to provide continued operations, salaried, contracted, and regular part-time staff have continued to work through telecommuting, limited physical reporting, and have been compensated through provisions provided through the Families First Coronavirus Response Act and provisions of Ohio Revised Code 3319.08 and 3319.081.

NOW, THEREFORE, BE IT RESOLVED, the Big Walnut Local School District Board of Education authorizes the Superintendent and Treasurer/CFO to provide continued payments to salaried, contracted, and regular part-time staff as deemed appropriate under Federal and State requirements for the current contract year.
