



**Agreement between Nationwide Children's Hospital, Inc.
and *Big Walnut Local Schools***

PARTIES: The parties to this Agreement are the Nationwide Children's Hospital, Inc. (d/b/a/ Nationwide Children's Hospital Center for Autism Spectrum Disorders) and *Big Walnut Local Schools*.

PURPOSE: The purpose of this Agreement is to describe the various responsibilities, functions, and objectives of the parties to the Agreement and terms of the Agreement related to financial arrangements, professional standards, supervision of services rendered, and record-keeping with regard to Behavioral Consultation Services.

TERM: This Agreement is entered into to provide consistent, quality services on behalf of the district in the form of behavioral consultation services for *Michael Clayton* (hereafter referred to as "Client") beginning *August 7, 2023*. The total contract allotment is not to exceed **\$2,580.00**.

RESPONSIBILITY OF NATIONWIDE CHILDREN'S HOSPITAL CENTER FOR AUTISM SPECTRUM DISORDERS:

1. Shall provide consultation services in adherence to the professional standards of practice and maintain current licensure for all qualified personnel.
2. Personnel are to communicate verbally and/or in written form as to recommendations for each Client without violating the rights of the Client, and with reasonable frequency.
3. Shall bill for services monthly, to be submitted to *Big Walnut Local Schools*, within 180 days of the service.

RESPONSIBILITY OF *Big Walnut Local Schools*:

1. Shall make records, documents, and staff related to Client available to the consultant.

2. Shall communicate verbally and/or in written form as to services needed (referrals), updated conditions, and questions regarding recommendations.
3. Shall provide prompt payment for services provided upon receipt of billing and properly completed service documentation from Nationwide Children's Hospital Center for Autism Spectrum Disorders.

COST OF SERVICES TO BE PROVIDED:

Consultation services from Nationwide Children's Hospital Center for Autism Spectrum Disorders will be reimbursed at a rate of \$172 per hour.

CANCELLATION:

This Agreement can be canceled by either party based upon thirty days written notice.

This Agreement has been signed and entered into by the parties noted below for the identified dates. This contract may be amended upon written Agreement by both parties.
