TRAVEL TIME: Travel time will be charged in the event that a local interpreter can not be assigned to your location for the requested assignment time. In this event up to two hours of drive time will be added to the cost of the interpreting services. Travel time will be billed at the above stated rates after the 2-hour minimum is satisfied. For example: If the interpreter has to drive one hour round trip for a half hour assignment, he/she would bill for a total of 2 hours. If the interpreter drives a half hour each way for a two-hour assignment, a total of 3 hours would be billed.

CANCELLATION POLICY: In order to avoid a cancellation fee equal to the total requested time of the appointment, the agency or the hiring entity must provide 24 hours notice. Sunbury, Ohio 43074, is established to provide American Sign Language (ASL) services for deaf and hard of hearing patients

MISSION

To provide quality substitute sign language interpreting services for deaf and hard of hearing students on an as-needed basis.

SERVICES COOPERATION

RJP Interpreting, LLC, shall render and provide the following services that include, but are not limited to:

- 1. Provide quality sign language interpreting to deaf and hard of hearing students on a substitute basis when contacted by designated employee(s) of BWLS who have the authority to request services.
- 2. Submit a monthly invoice to BWLS for services rendered.
- 3. Keep record of FBI background checks for individuals that are providing sign language interpreting services and provide them to BWLS as requested.

Big Walnut Local Schools shall render and provide the following services that include, but are not limited to:

- 1. Contact RJP Interpreting, LLC, at 740-803-8266 or rjpinterpreting@gmail.com, as soon as it is known that substitute interpreting services are needed.
- 2. Rate of payment: Payment of \$65.00 per hour with a two hour minimum. Round Trip travel time for the scheduled interpreter will also be charged at the aforementioned rates. To avoid the cancellation fee, RJP Interpreting, LLC (740-803-8266) must be contacted at least 24 hours before the scheduled interpreting assignment. Otherwise, a cancellation fee will be charged for the entire time of the scheduled assignment.
- 3. Payment will be mailed to RJP Interpreting at PO Box 224 Delaware, OH 43015, or paid by direct deposit to RJP Interpreting bank account of record within 30 days of receipt of invoice
