The Board of Education (the "Board") of the Big Walnut Local School District, Delaware County, Ohio (the "School District"), met in Regular Session on November 19, 2015, at 6:30 p.m., at the Big Walnut High School Media Center, 555 South Old 3C Highway, Sunbury, Ohio 43074, with the following members present:

**RESOLUTION DECLARING TRANSPORTATION TO BE IMPRACTICAL
FOR CERTAIN IDENTIFIED SCHOOLS
(R.C. Section 3327.02)**

WHEREAS, On November 19, 2015, the Board passed a resolution declaring the students identified below to have been determined to be residents of this school district and eligible for transportation services; and

WHEREAS, after a careful evaluation of all available options, it has been determined that it is impractical to provide transportation for these students to their selected schools; and

WHEREAS, the following factors as identified in Revised Code Section 3327.02 have been considered:

1. The time and distance required to provide the transportation
2. The number of pupils to be transported
3. The cost of providing transportation in terms of equipment, maintenance, personnel, and administration
4. Whether similar or equivalent service is provided to other pupils eligible for transportation
5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules
6. Whether other reimbursable types of transportation are available; and

WHEREAS, the option of offering payment-in-lieu of transportation is provided in Ohio Revised Code;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BIG WALNUT LOCAL SCHOOL DISTRICT, DELAWARE COUNTY, OHIO, A MAJORITY OF THE MEMBERS OF THE BOARD CONCURRING, THAT:
